WKQZ'S "WIN SLEEP TOKEN TICKETS' CONTEST OFFICIAL RULES

The Station will conduct the **WKQZ** "WIN SLEEP TOKEN TICKETS" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>On-Air</u>: Listen to the Station each weekday at 7:00am ET during the Contest Period. The Station will announce a new text keyword each weekday at 7:00 a.m. Then: Send a text message to the number 1-800-976-2593 with the keyword correctly spelled before 8:00am local time that day. Texting the keyword spelled correctly will make the listener eligible to win the daily prize.

All entries must be received by 7:59am ET each day of the contest to be eligible for the Daily Prize. Standard text messaging rates, as established by an individual's wireless carrier may apply, and Sponsor assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Sponsor. By entering the Nationwide Contest using the texting entry method, you consent to the receipt of a bounce-back confirmation text. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant

4. **Winner Selection.** On or about 8:00am ET each day of the contest, Station will select one (1) entry to be the Daily Prize winner in a random drawing from among all entries received by Station during the Contest Period as of the entry deadline. The winner will be awarded the Daily Prize Subject to verification of eligibility and compliance with the terms of these rules. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within

three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
